In order to rent a Premium, Luxury, Large Sport Utility, Pick-up Truck, Cargo Van and 10-15 Passenger Van, Eligible Renters shall be twenty-one (21) or older.

**Leisure Rental:** The account may use [redacted] when renting for leisure use which is exclusive of coverage. Please refer to the agreement for details.

**Long-Term Passenger Van:** Contact your dedicated account manager to setup a consecutive 8+ month 12 or 15 Passenger Van rental.

### Terms & Conditions

**Daily Rates:** Based on a 24-hour billing cycle.

**Mileage Charges:** Base Rental Charges for rentals in the U.S. include free miles as set forth above. Any additional miles will be charged at the rate set forth above.

**Inspection:** Customer agrees to require its Eligible Renters to perform daily visual inspections on rental vehicles including but not limited to the inspection of headlights, running lights, brake lights, and turn signals, the identification and notation of damages and the checking and maintenance of all fluid levels and manufacturer recommended tire pressure. See Agreement for full details.

**Maintenance:** Upon three (3) days' prior notification from EAN or an Affiliate, Customer agrees to make themselves and each vehicle available for the purposes of inspection and/or maintenance every thirty (30) days. See Agreement for full details.

**Age Requirements:** Customer shall be age 21 or older in order to rent any vehicles not considered "Light Duty" by EAN.

**Exclusions:** Rates do not include applicable taxes, surcharges, refueling, one-way, drop-off, delivery, pickup, or mileage charges; or, except as set forth below, any optional products or services such as damage waiver ("DW"), or liability protection ("LP").

**Protection Products:** Damage Waiver includes Full DW (\$0 Deductible); Liability includes Combined Single Limit of \$500,000.

**International Discount Rates will apply:** Damage waiver, theft and liability included. Deductibles apply based on country and vehicle class.

#### Gas refueling options

Vehicles are provided with a full tank of gas at all Enterprise and National airport locations. At off-airport locations, vehicles may be provided with less than a full tank.

Both Enterprise and National offer our renters several refueling options. Refueling rates vary by location, and the option selected. Travelers may choose one of the following:

- You refuel — The renter replaces all gallons used before returning the vehicle to avoid all refueling charges.
- Prepay — At the time of rental, renters may purchase a full tank of gas at competitive industry pre-purchase fuel prices. This is available at all airport and select off-airport locations.
- We refuel — The renter will be charged the refueling rate based on current local, per-gallon price, plus a fee of up to 50 percent. Corporate locations will cap the maximum refueling charge at \$2 per gallon above current per-gallon prices.
