2024-2025 Academic Year Penalties, Fees, and Fines

## **Housing and Dining Violations**

Offense	Penalty
Improper Check-In/Check-Out Failure to Complete An RCR Failure to Provide Off-Campus Contact Information	\$50 Fine; Unable to Appeal Damage Charges at Check-Out
Failure to register for Winter Term Housing	\$50 Fine; Students are not able to stay in Winter Term housing
Disposal (Removing of Belongings from Room)	\$25 per item, plus labor cost at \$35 per hour (Additional Charges for Disposal Required Special Procedures)
Failure to Vacate Residence Hall Room and Return Keys by Stated Date and Time Failure to Checkout at Announced Hall Closing Time	Charged \$50 per hour (Limited to \$400 per day)
Lock Change and/or Failure to Return Key Resulting in Lock Change	\$60 per Lock
Lockout Charge	Students will not be charged for lockouts during the first two weeks of fall & spring semesters. After second lock out students will meet with their area coordinator or designee.
	\$10 per lock out after the third lock out for the academic year
Pet Rule Violations	\$100 per resident of the college housing unit and possible referral to college conduct system (plus repair or replacement and additional cleaning cost assessed at the time of checkout).
Unauthorized Party	Up to a \$100 per resident assigned to the housing unit plus the cost of
Violation of Party Policy	damages discovered following the unauthorized party.
Unauthorized Room Change	\$100, plus possible relocation
Room Change not Complete by Deadline	

## **Student Motor Vehicle and Bicycle Fines**

Vehicles found in violation of a third offense of the parking regulations will be towed immediately.

Towing and applicable storage costs are at the owner's expense. Three violations will result in removal of cars from campus. Additional parking restrictions and fee listings are available from the Office of Campus Safety at <u>www.oberlin.edu/campus-safety/</u>.

## **Library Violations**

Offense	Penalty
Failure to Respond to Recall Notices	\$10 per day overdue fine, referral to honor

Reserve Room Penalties	\$2 per hour overdue fine

## **Other Violations**

If any of these violations occur, a member of the Office of Residence Life and Dining Services or the Associate Dean of Students will speak to the student to hear their side and, if convinced the violation occurred, will impose the scheduled fine and penalty using their discretion. A community board hearing is not required. However, the student may appeal to the Community Board board if they think there are mitigating circumstances.

Damage to College Property	Disciplinary action plus repair or replacement costs
Tampering with life-safety equipment, e.g., fire	Up to \$300 and disciplinary status, plus repair or
extinguishers, smoke detectors	replacement costs
False or negligent fire/life-safety alarm activation	Up to \$300 fine and disciplinary action, plus repair or replacement costs
Theft or misappropriation of college property	Disciplinary status, plus repair or replacement costs
Failure to return Art Rental on time	\$10 per day per rental
